Consists of medical and drug data from employers and health plans for several million individuals annually, encompassing employees, their spouses and dependents who are covered by employer-sponsored private health insurance in the US.

Multi-State Medicaid Database

Contains the medical, surgical and prescription drug experience of millions of enrollees from multiple states, including records of inpatient services and admissions, outpatient services and prescription drugs.

Medicare Database

Includes the employer-paid portion and out-of-pocket patient expenses for both Advantage and Supplement plans, as well as the Medicare-covered portion of payment (represented as Coordination of Benefits Amount, or COB) for Supplement plans.

Health and Productivity Management (HPM) Database

Links data on workplace absence, short- and long-term disability, and workers' compensation with medical/surgical claims and outpatient drug data.

Benefit Plan Design (BPD) Database

Contains detailed information about benefit plan characteristics for a subset of the health plans represented in the MarketScan Commercial and MarketScan Medicare Supplemental Databases.

Lab Results Database

Links outpatient drug data with enrollment and laboratory test results.

Health Risk Assessment (HRA) Database

Provides a claims-HRA linked data set of specialized data to evaluate the contribution of patient behaviors to health outcomes — including self-reported data on clinical variables that may otherwise be unavailable.

Dental Database

Integrates medical, drug and dental databases to help researchers investigate relationships between dental care, use of pharmaceuticals for oral health and medical conditions.

Mortality Database

Integrates death information with enrollment and claims data, supporting mortality outcome studies, including safety, effectiveness, healthcare evaluation, and population health trends.
